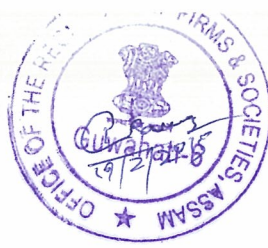

ac) Disbursement of profits, etc.

- (i) The members are not entitled for any remuneration. They shall however be entitled to be reimbursed all travelling expenses incurred by them in the course of discharging the function of the Organization. Any income by way of generation from projects as per the aims and objects, donations & grant-in-aid, subscription, etc of the Organization will be fully utilized for the purpose of the Organization and will not in any way or form, i.e. kind, cash, gifts, profits, interests, dividend or otherwise will be made to any of the members who are associate with the Organization presently or was associated previously and their relatives.
- (ii) Any part of the property or income of the Organization is not to be used or applied or ensures directly or indirectly for the benefit of any person specified under sub section 3 of section 13 of the Income Tax Act, 1961.
- (iii) The profits generated by activities of the Organization are to be utilized solely for achieving the objects of the Organization

ad) Dissolution

In even of the dissolution, the assets remaining after payment of any liabilities after will be handed over to like minded Organization operation in the North East India. It will not be utilised by any members for their own benefit.

ae) The deed of Memorandum of Association or the Organization is irrevocable.

af) The Organization if required will invest in the modes as specified under the sub section 5 of section 11 of the Income Tax Act, 1961.

ag) The objects and activities of the Organization is not for any particular caste, creed, community religion.

ah) Intimation to amendments

Any amendments and/or alteration to the rules without changing the basic structure of the Organization for which it is established will be intimated in due time to the Registrar of Society, Guwahati, Assam and the jurisdictional Chief Commissioner of Income Tax/Commissioner of Income Tax.

ai) Change in rules

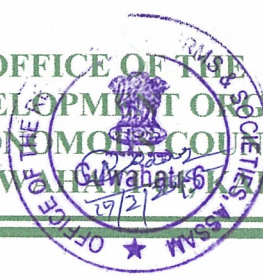

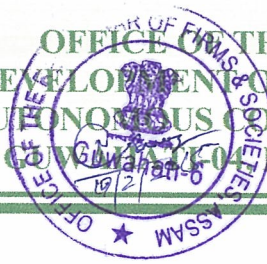

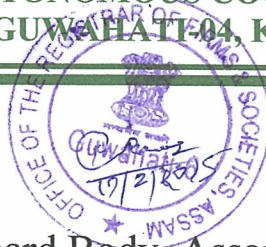

## 5. MEMBERSHIP :

a. Qualification to become Members: The membership of the society will be given to any Indian Citizen who:

(i) He/ She has attained the age of eighteen years.

(ii) Promises to abide by the rules and bye-laws and all the decisions taken by the association in respects of the amendments of the rules and bye-laws.

(iii) Subscribed in writing to carry out the best of his/her capacity the objects of the association.

b. **Subscription, Donation etc.** : All the members are liable to subscribe lump-sum amount as membership fees/subscription and donation may also be liable to subscribe towards the Society, so fixed by General Meeting time to time.

c. **Collection of fund** : The fund of the society will be collected from membership subscription/fees, donation from members/well wishers, grants from the Govt. organization and from its own resources, if any.

d. **Control of fund** : A bank account will be opened in the name of the society in any National Bank of Post Office, which shall be operated by the Chief Chairman of the Society.

6. **Procedure of the General Meeting** : The General Meeting will be held at least one in year.

7. **Quorum of the General Meeting** : In presence of 1/3<sup>rd</sup> members of the total members, the

Quorum of the General Meeting will be formed, but no quorum in case of adjourned meeting is needed so far.

8. **Election procedure of the Executive Committee** :

The Executive Committee will be constituted through democratic procedure amongst the meeting of the member of the Society in any General meeting.

9. **Short description of the Executive Members** :

Primarily the Executive Committee is consists of 30 members, which includes Chief Chairman-1, Vice Chairman-2, Secretary-1, Asstt.-5, Treasurer-1, Members-20, subject to increase in due course if felt necessary.

10. **The term of the Executive Committee** :

The term of the Executive Committee will be 3(three) years, subject to increase or decrease in due purse if felt required.

11. **Procedure of Re-election of the members of the Executive Committee** :

If necessary, Re-election will be held according to the Election procedure.

12. **Procedure of the meeting of the Executive Committee:**

The Executive Committee will be held at least once in every two months or so far both Functioning and management of the society.

13. **Quorum of the meeting of the Executive Committee:**

In pursuance of 2/3<sup>rd</sup> members of the total Executive Members, the quorum of the Executive Committee will be formed, but question of quorum in case of adjourned meeting does not arise.

14. **Expulsion of undesirable member:**

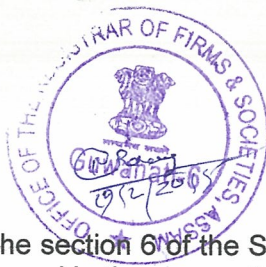
If any member goes against the Rules and Regulation of the Society, then the same member will be expelled from the Society.
